

Typhoon® Slide Giveaway Official Rules

NO PURCHASE IS NECESSARY TO ENTER OR WIN. A PURCHASE DOES NOT INCREASE THE CHANCES OF WINNING.

1. Eligibility: Sweepstakes (the “**Typhoon® Slide Giveaway**”) is open only to those who sign up at the online sweepstakes page at **www.srsmith.com/winatyphoon** and who are **18 years of age** as of the date of entry. The sweepstakes is only open to legal residents of **the U.S. and Canada** and is void where prohibited by law. Employees of **S.R.
